We are a non-profit registered charity providing social services primarily in Surrey, Delta, White Rock and Langley. We believe in helping people help themselves. We believe in collaborating with individuals, businesses, community groups and government to create focused, effective and responsive resources for the community.

We envision a healthy community as a safe and clean environment where we all have a sense of belonging. It is a place where each of us has the opportunity to work and learn, and to develop and realize goals that are meaningful and fulfilling.

Isolation Centres are part of our Homelessness Services in partnership with BC Housing. These sites provide much needed shelter and support for individuals who are homeless and may be required to physically distance or isolate due to Covid-19 related concerns.

Options Community Services is seeking a Team Lead for a time-limited contract for 3 months with the possibility of extension/until the return of the incumbent. The Team Lead will provide temporary, emergency care. They will plan and implement strategies allowing residents to obtain the skills necessary in securing accommodation and maintain independence. The Team Lead will interact with residents in a positive and supportive manner and work collaboratively with the resident in attaining designated goals.

This role requires the ability to work in a dynamic environment which may call for adaptation to the emerging trends/demands. A high level of motivation and sensitivity is required to effectively deliver services to a variety of individuals.

HIGHLIGHTS OF KEY RESPONSIBILITIES

- Provide a safe home, which includes securing the premises, maintaining the property to ensure safety, ensuring that unsafe actions by residents are responded to, and ensuring staff's safety.
- Take referrals on a 24 hour basis and do extensions of stay when needed. Data/information entry, electronic and written, into resident files and logs. Intake and orientation of residents referred to the Isolation Centres.
- Establish clear, simple and consistent limits for the residents. Encourage and facilitate the participation of residents to create a safe, positive atmosphere.
- Maintain awareness of any issues experienced by the residents and inform the supervisor. Supervise basic life skills chores or teach a resident how to complete them in a supportive manner. Encourage basic hygiene for all residents.
- Identify resident barriers and jointly with the resident, come up with a plan to deal with the issues presenting. Provide information and resources to the residents where appropriate, to deal with presenting issues/barriers. Is a positive role model at all times. Encourage appropriate behaviour in residents at all times.
